The program also aims to identify and recruit local foster and kinship carers so that children stay in Doomadgee and remain connected to their community and families.

9.02 Doomadgee Cultural Festival

Background: In May 2019, Elijah attended the monthly Ordinary Council meeting to introduce the idea of hosting an annual cultural festival in Doomadgee to celebrate and showcase traditional indigenous culture and dance. Council provided a letter of support for inclusion in a funding application to Arts Queensland.

Elijah Douglas joined the meeting to provide an update on the Doomadgee Cultural Festival which will take place in Doomadgee from 3rd to 5th October 2019. Arts Queensland are yet to provide a response regarding the funding application, but the Carpentaria Land Council has pledged to provide financial support. Elijah is seeking funding from the Council to the value of \$20,000.

- Trachoma Screening conducted by the Department of Health has been rescheduled for 21 25 October 2019. The next pre-screening stakeholder meeting will be held on Wednesday 2 October at Council's office.
- A PhD researcher from the James Cook University has written to Council requesting permission to conduct research in Doomadgee relating to the "Kapani Warrior" program. The letter was tabled for discussion at this meeting and *permission was granted by Council.*
- Andrew Cunningham of Data Central Pty Ltd has written to Council proposing new signage for the approach to Doomadgee airport in honour of two long-serving Council employees, Clinton Taylor and the late Meredith Kingsley. The proposed signage (which would be donated to Community by Data Central) was presented at the meeting and *Council confirmed their support for the initiative.*
- In May 2019, Council requested an extension of time to finalise it's 2017/18 General Purpose Financial Statements ("GPFS").
