Serious Crimes

John Fowles advised:

- over the last couple of months there had been a high volume of serious crime, where alcohol seemed to be the main contributing factor, so extra police were brought in to assist,
- sly grogging is hard to tackle due to everyone trying to get around the system. Quite often by the time the Police are notified. it is too late,

Acting Mayor, Jason Ned advised;

 the community have not been happy with the laws that the AMP has in place for some time and that he was putting together a group to present their concerns to the local member, to encourage change to these current laws.

Other Notes:

- There needs to be both Police and Community consultation in respect of any changes to the AMP.
- DATSIP are intending to visit the Community in mid to late November 2019 for discussions with Council, that will include the AMP. It is agreed that these discussions should include but not be limited to the following:
 - o Unless an offense can be proven, it is not an offense

- Illegal to have or bring alcohol into the Doomadgee "region"
- o The need to make the no alcohol zone bigger
- Currently there so many ways, and road accesses, being used to bring alcohol back into the community – what can be done to reduce these this.

Speed Limits around and within the community

In consultation with Police, Council are reviewing the speed limits to be reduced as follows;

- Approaching the township of Doomadgee the main road will be reduced to 80klms per hour
- Nearing the Roadhouse speed will be reduced to 60klms; and
- Within the town of Doomadgee speed will be reduced to 40klms.

The Radio Station will be requested to broadcast a reminder to community that the current speed limits in any built up area in Queensland is currently 50klms.

When the new speed limits come into effect, these will be broadcasted to the community along with a message that everyone has an awareness period of one month to adjust to the new limits. During this period anyone caught speeding will receive a warning for the first offence however once this period expires, fines will be issued.

Council will source funding for works to have Crossings, Speed Humps and signage for GIVE WAY and STOP signs, which will be placed at the School, Hospital, Aged Care, Bakery and approaches to the Supermarket.

Complaints against Traffic Police

Issues were raised that the Community are feeling targeted in the way they are being treated when they are stopped by Traffic Police and in some cases, it has been reported, that they can be quite rude.

John Fowles advised that he would be happy to register these complaints on behalf of Community.

Getting more involved and engaging with Community

Doomadgee Police would like to get more involved and engaged with the Community by running Blue Light Discos, Movie nights, football games and are looking at using the basketball area instead of inside at PCYC/Sports and Recreation Club.

Council has no objection to this and advised that the "PCYC" building will be undergoing renovations, hence there will be no ablution facilities during that time and alternative arrangements will be required in that respect.

Drug & Alcohol Issues

Doomadgee Police would like to work together with community and set up a Local Drug and Alcohol Community Team now that the Police have taken over as Lead Agency.

This concept will be discussed with DATSIP during the consultation process for any AMP review.

Minor Offences

Police and Council, in consultation with Community Elders and the Justice Department, will look at a better way to deal with minor offences.



John Fowles will make contact with someone from the Justice Department to see how we can go about it and how it operates.

Doomadgee State School Improvement Priorities are;

- every student, every day as engaging, safe, respectful learners
- every student learning and experiencing learning concepts
- success towards competency is essential
- whole language regime
- to teach phoenix well.

The numeracy and literacy skills of every are being assessed with the intent to review teaching methods to improve these skills and hopefully attendance at the same time.

Improvements are just starting to kick in now with many students.

- Some children have been missing out and all gaps need to be filled with literacy and numeracy;
- Poor attendance because children feel they aren't smart enough and aren't coping;
- Bullying a problem;
- Children's lack of respect for teachers.

11.03 Animal Management:

Veterinary visits are an expensive process and money in this area needs to be reduced.

When vet returns for their next visit, horses need to be culled. Horses are spreading Goat Weed seed which is infectious and can be very harmful to humans, causing cases of gang green.

Funding required for boundary fences around town to keep horses out.

This will be a major project to eliminate Goat Head Weed in the Community.

11.04 Environmental Health:

Michelle Newman; Queensland Government Senior Environmental Health Officer is Working with Doomadgee Council Environmental Health Worker to create an activity workplan, environmental management procedures and BIO Security for Doomadgee. An update of current qualifications will be provided at the next visit in early November. The funding from the Qld Government to provide animal management and environmental health services is considered 'Contribution Funding' and is expected to be fully expended each year.
