I refer to your request for special holidays for 2023.

Pursuant to Section 4 of the *Holidays Act 1983*, the Minister for Education and Minister for Industrial Relations has appointed:

- 7 July 2023 a holiday for the Shire of Doomadgee for the purpose of the NAIDOC Day
- 25 August 2023 a holiday for the Shire of Doomadgee for the purpose of Doomadgee Day

Please note that it is only special holidays appointed in respect of an annual agricultural, horticultural or industrial show (show holidays) which are public holidays. On a public holiday, employees will be entitled to refuse to work in reasonable circumstances without loss of pay and to be paid penalty rates for work performed.

Should there be a need to request repeal of one or more of the above special holidays (whether or not appointment of a replacement special holiday is also requested) or appointment of an additional special holiday, 30 days prior notice of the requested repeal or appointment is to be given to the Minister. This will allow time for the Minister to decide the request, notify any repeals and/or appointments in the Queensland Government Gazette and for the requesting local government to give notice of holiday changes to its community.

Replacement of a show holiday with a special holiday on another date should be carefully considered as the replacement show holiday will only be a public holiday if it continues to be in respect of an annual agricultural, horticultural or industrial show.

Notification of the appointment of the 2023 special holidays was published in the Queensland Government Gazette on 2 December 2022.

A copy of the gazette can be accessed on the <u>Queensland Government's publications website</u>, the special holidays notifications commence on page 433 of the gazette.

Doomadgee Future Planning Report

EXECUTIVE SUMMARY

1 Overview

The Department of Seniors, Disability Services and Aboriginal and Torres Strait Islander Partnerships' Remote Indigenous Land and Infrastructure Program Office (RILIPO) is working in partnership with the Doomadgee Aboriginal Shire Council (DASC) to develop a Future Planning Report to establish pathways for DASC's future growth. Strategic future development is critical to increasing the overall strength and diversity of the community's economic base, creating jobs, and actively promoting tourism, while maintaining and beautifying the natural and cultural value of the area.

Doomadgee is a Deed of Grant in Trust (DOGIT) community that sits along the gulf stretch of the popular tourist drive, The Savannah Way, which extends all the way from Cairns in Far North Queensland to Broome, Western Australia. Doomadgee is situated close to the scenic Boodjamulla National Park (formerly known as Lawn Hill National Park), and Adel's Grove, and is the final township along the Queensland section of the Savannah Way, sitting only 140kms from the Northern Territory border. The Doomadgee community lies along the Nicholson River, a permanent freshwater source that flows from the ranges behind Boodjamulla National Park.

Despite officially appearing on the Savannah Way map, Doomadgee is not currently equipped with suitable facilities to accommodate passing tourists and benefit from the existing tourist economy. There are no designated tourist camping areas and minimal facilities for visitors. DASC is keen to develop its tourism industry by increasing accessibility for tourists, while showcasing its strong and vibrant culture, and protecting the natural landscape for generations to come.

2 Remote Indigneous Land and Infrastructure Program Office Commitment

To establish the specifics of the overall design and intent for future growth of the community, including but not limited to tourism and commercial aspects, RILIPO is coordinating the preparation of a 'Future Planning Report' (the Report) in partnership with DASC. The Report will outline the strategic vision of the community and identify the technical input required for future development opportunities for the community. The Report will provide a clear pathway for DASC to implement their aspirations while incorporating appropriate planning and infrastructure development.

The intent of this project is that the successful contractor/s, secured through a tender process, will identify and record the community's vision, goals and critical success factors, by developing a series of project plan outlining the schematic design, estimated capital works costings, required Development Approvals, cultural heritage, native title and land tenure requirements, development stages, planning ideas and associated timeframes, as well as any other applicable legislative requirements. This will be completed in consultation with RILIPO, DASC, and other identified stakeholders.

3 Key Stakeholders and Strategic Partners

4 Vision

The vision for this project is to support the aspirations of DASC and the wider community for the future growth of Doomadgee, in accordance with best practice development that promotes sustainability and longevity. Future growth options should be designed in a way which facilitates an increasing number of tourists whilst also maintaining and highlighting the natural and cultural heritage of the area.

The Report will encompass several elements of the Doomadgee community's intended prospects for future development. This will include an initial review and update of the Strategic Framework in the local planning scheme, to incorporate current aspirations for tourism and commercial development, neighbourhood character, and community infrastructure.

This project will also include the development of a series of precinct plans to provide more in-depth planning options for certain precincts. The precinct plans will include a new business hub on the Savannah Way, with provision for retail, seasonal restaurants, and arts and cultural outlets; a tourism precinct plan for the development of a caravan park, campground, and day-use visitors area; and a riverfront design plan for the banks of the Nicholson River. The Report should also consider how the local community can benefit through the provision of facilities for active lifestyle spaces, expansion of green corridor areas, increased walkability and cooling the city.

The successful contractor/s will be suitably qualified, resourced and experienced to investigate the opportunities and limitations of development in a rural and remote context to ensure that cost considerate plans are produced for the community. Once the successful contractor/s are engaged, all stakeholders, in particular DASC, will have the opportunity to engage with the project team/s in order to ensure the production of well informed and appropriate documentation.

With in-principal approval from, and in consultation with DASC as the local government authority, the successful contractor/s are required to produce robust documentation which will be utilised to inform the future development of the community.

RILIPO will cover the costs associated with the development of the Future Planning Report. A staged approach to the project using more than one contractor may be required to ensure that each aspect of the project is developed to a high standard.

5 Next steps

RILIPO will manage a Queensland Government Procurement tender process for the Precinct Plan by early January 2023. To achieve that deadline, in-principal approval from stakeholders is required.


The successful contractor, once engaged, will commence the consultation and planning process.
