- 8.1.1.1 Meeting Monday with Wayde Cheisa for future development of Doomadgee. If Councillors have anything to develop need to let the CEO know so that he can bring it up in those meetings.
- 8.1.1.2 Meetings every month with Gulf Savannah about how to tap into tourism/economic development from Cairns to Doomadgee.
- 8.1.1.3 Cyclone Kirrily the school, the store, roadhouse and bakery and the nursing home have transported in approximately 11 tonnes of food and goods.

Disaster Management have organised – flying in all the goods – being a total of 11 planes. Most probably will carry out another drop in the next 2 or 3 weeks. The minute Council calls the Disaster Management Group they are there to help us.

The Hospital, School, Guest House and Sport and Recreation Centre are able to open up the doors in a disaster for accommodation and help.

If the banks happened to break if the flood rose the oldies from the Nursing Home would be able to be shifted very quickly to the Hospital. Last year the water rose very quickly and had to move the people immediately.

8.1.1.5 Once the Water Treatment Plant has been sorted – once all the issues have been refined the staff will be able to carry out the jobs that they are meant to be doing instead of sitting around monitoring the aging infrastructure.

Have 2 million with the Government and trying to get the right program going – at the moment only dealing with the surface problems and not the core problems. Have a meeting tomorrow and maybe the Government will actually see what Council needs to have fixed to be able to run it properly.

- 8.1.1.6 Act for Kids the current practices with the Officer not doing what he has been employed to do.
- 8.1.1.7 Live North Queensland need 2 people from Doomadgee to do a 2 minute video about Doomadgee will check with Zac to see if he is able to do it.

Jobs North Queensland – all jobs in Doomadgee can be advertised here, so they will get a good following of people looking for work.

- 8.1.1.8 Normal monthly meeting conversations centred mainly around housing and roads building capacity change designs? Local recovery tourism and livestock.
- 8.1.1.10 Source Global have come up with a method to extract water hydropanels. Maybe a good idea to be able to sustain a small outstation or a home. If this method was used, would not need to dig a bore at any outstations 8 Mile, Gumhole, Emu Creek all houses built from funding. CEO wants to do a business case and present to the Government and advise that with this information being provided from Source Global the outstations will not require electricity and water. Source Global will send costs and the estimation of how many panels would be required.

8.3 DIRECTOR OF ENGINEERING REPORT

8.3.1 INDIGENOUS COUNCILS CRITICAL INFRASTRUCTURE PROGRAM (ICCIP)

Department of Local Government Racing and Multicultural Affairs update

The water treatment plant is still having trouble. There is a lot of slug sitting underneath the water and when the water rushes in and upsets the slug, then when the pumps are turned on at a massive speed it is disastrous and slug is going everywhere.

Need to be able to control the rate of the pump when first switched on to a slower rate so does not cause the slug to rise. Brian from AECOM is going to list the core problems for the water. Slug upsets the turbidity.

Once the wet season is gone and everything dries up will get all equipment in to fix up the pumps up top and the water treatment plant. At the moment have 2 x 2 megalitre tanks, need 4 megalitre tanks and also need another clarifier.

Every day the water treatment plant works overtime and the only time it makes any water is at night time – during the day it is going out at 12 litres a second and only making 20 litres a second.
