BUSINESS ARISING FROM MINUTES OF THE ORDINARY MEETING HELD ON 6.1 THURSDAY 20th APRIL 2023

Bob Gee will be here on 31st May for a meeting and will have a Senior Officer with him. Please Councillors could you all attend the meeting.

Troy the CEO thanked Pam for all her work and Mayor Jason and Cr. Athol Walden spoke on her efforts and thanked her. Troy also advised that Paul de Launay the Engineer was also leaving.

Engineers should come to Doomadgee with all the knowledge and should know exactly what they need to do. There has been too much chopping and changing with Engineers for a long time in Doomadgee. Need to see a process put in place to know that they are professional before being employed. Mayor wanted to see things going back to the way they were about 3 Engineers ago when grants were being applied for and Council Reports provided all the necessary information to the Councillors. Cr. Walden felt that the new road should have been built around the house at the bottom end before they were built and there would be no hold ups like we have now. He believes that once Council finishes this term the people will not want them back in the Chair again as the people and Community believe the Council has done nothing for them. CEO advised that was wrong and he would put something together on what has been achieved over the last 4 years. It can then be put on facebook. The streets have not been cleaned - need to employ more people to get that done.

Cr Walden advised that they Councillors needed to get their portfolios back so that they can follow up the particular matters that they are involved in. CEO had thought it was the responsibility of all Councillors to be up to speed on all matters. He is happy to put them back into the portfolios if that is what they want.

Need rights back so our children will learn and know about their Community. Kids need to get back to "On Country" and away from the trouble.

CEO advised that he had spoken to NIAA and has asked that someone come out and talk to our Community about the VOICE. No-one seems to understand anything about it and will most probably vote YES without

- 8.1.1.1 Have been talking regarding obtaining stand alone equipment solely for the dump. Procedures need to be put in place regarding plant and equipment and operating of the Waste Management Facility.
- 8.1.1.2 Tenders have finished for Doomadgee West restoration works and town streets. Have approved the purchase of a street sweeper to keep the streets clean and to stop the dirt and rubbish entering the drains. Council have been given \$1m for emergency work and CEO would like to use to clean out drains and then put on capping to stop the kids from climbing into the drains.
- 8.1.1.3 Nicki is working on outstation housing to see if those house can be put on the register. Need to invest back into those houses, 3 Gumhole, 2 Emu Creek, 8 mile and also 6 mile. If people pay rent then they can be fixed. Need to work out how power and water will be added. Conversations are on going. Find the 40 year lease agreement.
- 8.1.1.4 Aquaponics has a new employee now that John has left. Want to now the garden space near the Airport up to Aquaponics and work on the market garden.
- 8.1.1.5 Army personell attended meeting with CEO and Mayor and advised that they wish to attend Council more often about recruiting young people from Doomadgee.

- 8.1.1.6 NIAA Henry Enschong attended office and talked on training that leads to more jobs and how they can support it on the ground. Hopefully will see some changes in the operations.
- 8.1.1.8 QRA Recovery development, how can we tie in the Indigenous knowledge of backburning in with getting ready for Disaster Recovery.
- 8.1.1.9 BDS is coming up to being in Doomadgee for 12 months. How do we grow it so that BDA supports the Community and get them involved in the Community. They want to put an office near the plumbers shed and also close off the workshop to comply with WH&S. There were complaints about charging full price for after market parts then they are not genuine parts. Apprentices are getting charged out a full time workers rates. The Council truck has been used by BDS when the floods were on for getting parts into Doomadgee. Whilst bring their own parts in they were also carrying freight for Council which we could not access due to the floods.
- 8.1.1.10 RILIPO meeting with 2 consultants as well as Lauren and Gerhardt from DATSIP. There were discussions on an Industrial area, developing the foreshore from the town to the waterfall, commercial space right on the highway near the roadhouse, visitors information centre opposite the roadhouse, with maybe nature walks and similar. The consultants went away from the meeting to continue their planning and will come back to Council for endorsement.

If endorsed by Council will then take it to the Community for further endorsement. TMR and Department of Arts having funding for signs. Positive signs will need to be installed starting 3 ks away and going down to 600 m – eg visitors centre. Funding will be available for the Consultants through DATSIP. The Caravan Park that has been talked about would be low impact with only a toilet there and the park would grow as the usage is increased.

7.1 MANDY WHITE, PRINCIPAL, DOOMADGEE STATE SCHOOL

Mandy White introduced herself to everyone and apologised for not being able to attend the last meeting when scheduled, she stated that there was trouble and it was not possible for her to leave.

She also advised that she had previously injured herself in her last position and she has been travelling to Townsville for treatment which places a large toll on her time away from Doomadgee. She was able to attend Council for the NAIDOC Meeting held last week.

Mandy believes in putting the school children at the fore front and believes that life is a choice not a life of chance. She had been contracted to Doomadgee for three years so intends to help the children in any way she can. Just recently the school paid for Birth Certificates that were required when Birth Deaths and Marriages were in town. They will be taking the kids from years 9 and 10 for a transmission camp to Cairns which the School will be paying for, to open their eyes and broaden their horizons. She also advised that she came her for an express purpose so that the children from Doomadgee will be given the same opportunities as those in the South East.

CEO enquired about the sharing of facilities with the Community. He advised that in 2011 and 2012 the Government agreed and then the next Government said no.
