8.1.1 NWQROC discussing Bio Security Plan. Business as usual - concentrating on the roads.

8.1.2 Transparency to Community needs to be tightened up re advice on flooding especially when the river first starts to rise - Council needs to be ready.

Cleaning all the storm water drainage systems as the water was coming back up the storm water drains. Council had no idea what streets would be affected. Discuss with Government for funding.

Photos have already been taken before, during and after flood events.

Council discussed the need for more flood cameras leading further upstream of the Nicholson River to better predict future flood events. Council advised that Council had received a good response form other agencies in regard to how Council have handled the recent flood events in Community.

District Disaster Management Jeff Magnus and Elliot Dunn were helpful and said, "just do it", "let us know the cost afterwards".

Need to go to Canberra with Normanton, Burke and Doomadgee Shires to get support.

- 8.1.3 As discussed early on in the meeting. Tower will be installed at the back of the water treatment plant by the end of August.
- 8.1.4 Spoke about the supermarket and the problems. TCICA prepared to provide assistance with the contract.

Talk about "the Voice". All indigenous Councils from the Cape do not know anything about it. Government trying to arrange a meeting to come to Doomadgee to talk to all the Community. Council should be looking at things like the Treaty and how we address the Youth Problems not "the Voice".

8.1.5 Cr. Douglas was the stand in person for the Mayor and completed a presentation on behalf of Doomadgee. Council is concerned that the Police continue to raise the same issues and no changes in the way they follow up the problems that have been identified. Need to raise with TCICA to see if they can drive the change.
